

FLY & WATCH PRIVACY NOTICE

1. ABOUT THE PLATFORM AND THIS PRIVACY NOTICE

- 1.1. “**FLY & WATCH**” (which will also be referred to as the “**PLATFORM**” in this Privacy Notice), is a digital in-flight entertainment platform offered for access on Pegasus flights on your own mobile device (mobile phone, tablets, laptop computers). This platform service is provided in partnership between Immfly (Platform’s Manager) and Pegasus (Airline Operator). Therefore, both entities will act as data controllers of the personal data that you may submit to each of them.
- 1.2. This “**Privacy Notice**” covers the identity of the data controllers, the purposes for which your personal data will be processed when you use the platform service, to which third parties and for what purposes such data may be transferred, the applicable methods and legal basis for data processing and your rights regarding your own personal data.
- 1.3. The scope of this Privacy Notice is limited only to the processing of personal data in connection with the services provided over the Platform. You may review [Pegasus Privacy Policy](#) and [Immfly Privacy and Cookies Policy](#) for general information on the processing of personal data other than in connection with the Platform services.
- 1.4. For the expressions used in this Privacy Notice, unless they are not separately defined herein, the meanings under Turkish Data Protection Law numbered 6698 shall be attributed to them.

2. DATA CONTROLLERS

3. PERSONAL DATA COLLECTED

- 3.1. We obtain your data directly from you and transmitted electronically from your mobile device when you purchase paid content for the Platform, through the use of our websites or online forms, on the Platform. Please note that we do not process personal data for access or using free content on the Platform and we do not process special categories of data such as those relating to racial or ethnic origin, religion, political opinion, etc.
- 3.2. On the Platform entry page, anonymous data collected from the mandatory fields that are marked with an asterisk (*) and non-mandatory fields that are not marked, will not be consolidated with any personal data by Pegasus. Such anonymous data will only be consolidated with additional personal data that may be processed by Immfly, identified in Section 3.3 and 3.5 below, only if paid content is purchased on the Platform. Such anonymous information referred to in this paragraph covers gender, birth year and country of residence. Your access to the Platform may be fully or partially restricted if the mandatory fields are not completed.
- 3.3. In addition to the anonymous data collected on forms while accessing the Platform, other data

that may be sought and/or shared during the use of the Platform are processed as part of your use of the Platform. Your choices for the purchase of paid content, i.e. payment information (credit card holder name and surname, hashed credit card information), contact information (e-mail), information on your use and choices regarding the products offered and your requests, complaints and feedback regarding the Platform fall within this scope.

- 3.4. If paid content is purchased through Pegasus website, mobile applications and other Pegasus sales channels, payment and payment related personal data is processed solely by Pegasus as the data controller. If paid content is purchased on the aircraft through the Platform, payment and payment related personal data is processed solely by Immfly as the data controller.
- 3.5. In addition to the above, we collect aggregated/anonymous information regarding your activities regarding the use of the Platform.

4. PURPOSES AND LEGAL BASIS FOR PROCESSING

4.1. In connection with your use of the Platform, your personal data will be processed in accordance with the purposes and legal basis described in the following table. This Privacy Notice covers the following data subject: the Platform user. Thus, in each heading the information shall cover this data subject.

Receipt of your requests, complaints and feedback regarding the Platform and the response process is another example. Likewise, efficient request and complaint management will produce improved customer satisfaction. When achieving the said purpose, the fundamental rights and freedoms of data subjects are not violated. To achieve this, functioning efforts are carried out based on anonymous data obtained during Platform access unless paid content is separately purchased.

Personalizing user experience for the purpose of providing content we believe that will be of your interest on the Platform and as part of Platform communication.

Data controllers have legitimate interest in providing users with most relevant content among a wide variety of subjects and in order to achieve efficient services and enhance customer satisfaction. When achieving the said purpose, the fundamental rights and freedoms of data subjects are not violated. To achieve this, personalization is carried out based on anonymous data obtained during Platform access unless paid content is separately purchased.

5. THIRD PARTY RECIPIENTS OF PERSONAL DATA AND INTERNATIONAL TRANSFERS

For the purpose of providing you the Platform services and its content, and subject to your explicit consent for the international transfer of your data for the purposes stated in the consent checkboxes, your personal data may be transferred to third parties. These third parties may act as the data controllers' processors, or sub-processors at the instructions and on behalf of the data controllers depending on the nature of the data flow and relationship, and will have implemented appropriate safeguards to protect your personal information which to the extent they do not act as separate data controllers.

- 5.1. Your personal data will be shared with official authorities in the presence of a legal obligation, due judicial process, litigation and/or request by an authorized administrative of judicial body. Your personal data may be disclosed to administrative or judicial bodies if necessary to enforce terms and conditions regarding the Platform or the protection of operations or users. Your personal data may also be disclosed to third parties involved in a corporate restructuring, merger or sale.
- 5.2. Since Immfly provides services through servers established in Spain, your data will be transferred abroad under the conditions specified in this Privacy Policy. International transfer of your personal data is required for accessing paid content on the Platform and purchasing such content on the Platform directly from Immfly. Immfly will rely on your explicit consent for the international transfer of your personal data. Platform service is provided on servers belonging to Data Controller Immfly. The purchase of paid content through Pegasus sales channels does not result in your personal data being shared with Immfly or transferred abroad.
- 5.3. Please review the table below on the transfer of your personal data to the mentioned recipient groups in a manner limited to the specified reasons.

6. YOUR RIGHTS REGARDING YOUR OWN PERSONAL DATA

- 6.1.** You can always apply to the data controllers to: (a) understand if your personal data is processed; (b) request information on the processing of your personal data, (c) understand the purpose of processing for your personal data and whether these are used in line with this purpose; (d) know third parties to whom your personal data is transferred in Turkey and abroad and to inquire about the appropriate safeguards implemented for cross-border personal data transfers; (e) correct your incomplete or incorrect personal data processed and maintained; (f) request the destruction or anonymization of your personal data subject to the purposes for the processing of your personal data being fully exhausted; (g) have third parties notified of the transactions covered in items (e) and (f), (h) object to the results of any analysis of your personal data exclusively through automatic systems; and (i) request compensation for the damage arising from the unlawful processing of your personal data Your applications can be submitted to the relevant data controller at the contact means provided in Section 2 above in accordance with the application methods prescribed in Article 5 of the Communiqué on the Procedure and Principles Regarding Applications Filed with Data Controllers.
- 6.2.** We will resolve your inquiry at the earliest opportunity and in any event within thirty days.
- 6.3.** You must provide the data controllers accurate and complete information to enable the offer of Platform services and the improvement of your user experience. If you suspect that your data held by the data controllers is not correct, please notify us so that the necessary correction can be made. Please note that you will be responsible for any loss incurred by the data controllers and/or Sponsors and Service Providers arising from an incorrect or inappropriate disclosure made by you.

7. OTHER MATTERS

- 7.1.** Please review the general Privacy Policies of the data controllers referred in Section 1 above for information on security measures regarding the Platform services, cookies and internet-based

marketing functions and other matters that may be relevant for your personal data. For any questions, please contact the relevant data controller through communication means provided above.
